

2008 March 4, Tue

The Menon paandis kept the radiation up all night last night - casually targeting my head, abdomen in turns - I was shouting as loudly as I could every fifteen minutes or so for most of the night. It didn't bother them. The police paandis patrolling NM road on motorcycle.

Then a couple more paandi police to reassure the neighbourhood that they needed to do nothing, that the police were not all dogs, that "aa kutti" needed to be committed to an asylum, that the "Supreme Court" had to dispose of a petition by the paandis, and after that, everything would be all right, etc. They are just waiting for a "report" ...

So stalking, radiation exposure, sadism, poisoning, pornographic voyeurism, sex with minors, blackmail are not actionable crimes, the police need to see some testimonial letters.

A letter from the US attorney general, a letter from the "US President", a letter from the Defence Secretary, a letter from the "Home Minister". A testimonial from Nimhans, an opinion from the employers, a testimonial from the neighbours.

And with these testimonials, they negotiate their hafta and soft perks - like business class travel to foreign countries, all expenses taken care of, escorting foreign sex deviants and supervising their arrangements for committing more crimes.

Got back to my flat around noon. Meghana Menon immediately on sadism duty - she has been targeting me all day in my study, now 7:10pm. Monish Das now also in on the sadism action.

9:20pm, the Menons now targeting my chest and back - high heat sensation, sweating.

The paandis including Satan jr. and Nimp along with a bunch of their local paandis, outside on NM road - Satan jr. practicing his sob story - this time it was about a suffering "Jonathan" and a "gorgeous" girl.

10pm, the Menons increasing the radiation.
